REGULAR MEETING MINUTES

One gravel quote was received from Laveau Excavating Motion by Conley; seconded by Johnson to accept the submitted quote at \$17.50/yd-Class 5 and \$12.50/yd pit run. Motion carried. Materials will be available for purchase by township residents at the quoted price.

The culvert on Legarde Road has rusted through and is being repaired.

Motion by Johnson; seconded by Conley to approve the rate increase requested by Carlton Enterprises as follows:

Mowing-Town Hall.....	\$29 up from \$28
Janitorial Services.....	\$13/hr up from \$12.50

Motion by Laveau; seconded by Conley to accept the proposal for dust control through Carlton County to be applied on Matten Road (\$880). Motion carried.

Motion by Johnson; seconded by Conley to donate \$100 to Brickyard Days. Motion carried.

Motion by Johnson; seconded by Laveau to appoint R. Laveau, C. Anderson, S. Seglem, L. Johnson, J Dahl and C. Ankrum as potential election judges for the 2016 primary and general elections. Motion carried.
